1(C). The Growth and Dividend Plans under Principal Resurgent India Equity Fund have been merged with the respective plans under Principal Growth Fund effective the close of business hours of October 29, 2010.

1(D). Principal Floating Rate Fund has been renamed as Principal Near-Term Fund and the two plans under the Scheme i.e. Flexible Maturity Plan and Short Maturity Plan have been renamed as Conservative Plan and Moderate Plan respectively. The asset allocation pattern of the Scheme has also been revised and the Scheme has been restructured as an open-ended debt scheme. Short Maturity Plan ceased to be a liquid plan. The said restructuring has been effective November 29, 2010.

1(E). Pursuant to the restructure of Principal Child Benefit Fund, effective November 1, 2010, the name of the Scheme has been changed to Principal Conservative Growth Fund. Effective February 21, 2011, Dividend Option has been introduced. Accordingly effective February 21, 2011, the Scheme has two options viz. Growth and Dividend.

1(F). The asset allocation pattern of Principal Monthly Income Plan has been revised effective November 1, 2010.

1(G). Pursuant to SEBI Notification dated July 29, 2010, under Principal Global Opportunities Fund (PGOF) the Trustees have approved and adopted the 2nd option of Total Expense Structure specified by SEBI and accordingly the Annual Scheme Recurring Expenses structure of PGOF has been modified effective October 1, 2010.

1(H). The asset allocation pattern of Principal Balanced Fund has been revised effective November 29, 2010.

- There are no borrowings by any schemes of Principal Mutual Fund during the half year ended March 31, 2011.
- During the half-year ended March 31, 2011 there has been no change in the Accounting Policies.
- During the half-year ended March 31, 2011 various scheme(s) of the Mutual Fund had invested in securities of the Associate / Group Companies of the Sponsor. - The AMC made the above investments on account of their high credit quality and competitive yield for investment in debt instruments. In case of equity shares, investments were made because of attractive valuations and good growth of these companies or because they were part of the S&P CNX Nifty Index. In all cases these investments were done on arms length basis and in accordance with the investment objective and investment strategy of the respective schemes.
- During the half-year ended March 31, 2011, none of the schemes subscribed in the issues lead managed by the associate companies or subscribed to any issue of equity or debt on a private placement basis where the sponsor or its associate companies have acted as arranger or manager.
